### Punj Lloyd gets Rs 3254 crore Buildings and Infrastructure project

**New Delhi, April 15, 2014:** Diversified global conglomerate, Punj Lloyd, has signed a contract worth USD 540 million (INR 3,254 crores) for a Buildings and Infrastructure project with the Housing & Infrastructure Board (HIB), Libya.
